WHEREAS the Academic Senate understands that the COVID-19 pandemic has created emergency health and safety concerns that have severely disrupted regular University operations, and that the University's Public Health Working Group has raised a concern that if

large numbers of students travel home (including interstate travel) for the Thanksgiving holiday in November 2020 and then return to campus afterwards, it would likely create an unnecessary increased risk of

spreading the virus;

29 30 WHEREAS the Provost has asked the Academic Senate to consider an amendment to Section 3-B(5) that would allow academic-year faculty (i.e. on 9-month contracts) to be asked to begin work for the Fall 2020 semester on August 1, 2020, and to finish the fall semester before the Thanksgiving holiday break. This would allow faculty two weeks to prepare their classes before the Fall 2020 semester start date of August 17, 2020;

WHEREAS, the Executive Board is proposing that Section 3-B(5) be amended to allow this change in the period of service for academic-year faculty as follows (the new language is bolded):

"Except for academic recess and University holidays, unless agreed otherwise by individual contract, the period of service for academic-year faculty is from August 16 through May 15 of the following calendar year, and the period of service for fiscal year faculty is from July 1 through June 30 of the calendar year. In the event of emergency circumstances that severely disrupt the University's regular operations, after consulting with the academic units and the Academic Senate, the Provost may temporarily move the dates of the period of service for
