23	Call to Order
24	Academic Senate President Paul Adler called the meeting to order at 2:03 pm.
25	Approval of Minutes of October Senate Meeting
26 27	Academic Senate Secretary General Devon Brooks presented the November 2020 minutes for discussion and approval.
28 29	<i>Motion to approve the November minutes. Seconded and passed: 24 in favor, 1 opposed, and 0 abstentions.</i>
30	Call for Nominations to the Distinguished Faculty Service Award
31 32 33	Professor Julie Nyquist introduced the call for nominations for the Distinguished Faculty Service Award and Walter Wolf Award. She described selection criteria and procedures and encouraged faculty to submit nominations by the due date of March 2, 2021.
34	COVID 19 Impact Statement for Junior Faculty
35 36 37 38 39	Steve Bradforth (Dornsife Divisional Dean for the Physical Sciences and Mathematics) presented a COVID19 impact statement template designed by Dornsife initially with tenure track junior faculty in mind. The Provost has decided that impact statements should be optional and individual faculty should determine whether they want to include them in review materials. Further, the Provost decided that each school should determine whether/how they want to adapt the Dornsife

- 40 template and approach for different faculty tracks and different reviews. The template has been
- 41 shared with Deans of Faculty and the Executive Board (EB) encourages Senators to engage with
- 42 their Deans of Faculty around implementation.

43 **FEEC Survey Results**

- 44 In November, the EB asked the Faculty Environment and Employment Committee (FEEC) to survey
- 45 the faculty so that we can better understand their experiences working under COVID conditions. It
- 46 is hoped that results of the survey will be used to inform advocacy on behalf of faculty. Professors
- 47 Ashley Uyeshiro Simon, Jennifer Ailshire, and Laura Serna described methods used to conduct the
- 48 survey and initial university-wide findings based on data from 1,345 respondents. A full report will
- 49 be forthcoming and school-level data will be made available where sample size permits.

50 Draft Resolution on Senate Representation (1st Reading)

- 51 Recently, the EB has been asked to increase the number of Senators representing certain schools
- 52 due to the growth in their faculties, but the Senate Constitution does not stipulate how to
- 53 determine the number of Senators for each school. In response, Adler presented for a first reading
- 54 a draft resolution detailing proposed changes to the representation of schools on the Academic
- 55 Senate. He also described the principles used to determine the proposed changes. The proposal
- 56 does not change the number of Senators for most schools but adds Senators for five schools. The
- 57 Senate will vote on the Resolution at the January Senate meeting.

58 Draft Resolution on Retirement Benefits and Merit Increases

- 59 The Engineering School Faculty Council brought a draft Resolution on retirement benefits and a
- 60 draft Resolution on merit increases. Adler moved to table both resolutions for two reasons. First,
- 61 the Senate passed a Resolution in October that affirmed the premise of the draft Resolutions—
- 62 that faculty want retirement benefits and merit pay increases restored in FY22. Second, the new
- 63 elements— that retirement benefits be incorporated into employment contracts and that the
- 64 implementation date for the merit raise freeze could be deferred if circumstances justify it—
- ⁶⁵ require more exploration and vetting before the Senate considers them as Resolutions.
- 66 Motion to table the Resolutions. Passed: 36 in favor, 4 opposed, and 0 abstentions.

67 Draft Resolution on Puliafito Report

- 68 The Annenberg School Faculty Council proposed a draft Resolution on the Puliafito report, asking
- 69 the Administration to release the report. (Its authors offered to amend the Resolution to allow
- 70 redaction of the report if necessary.) Adler proposed tabling the draft Resolution because the
- 71 early drafts of the Senate's November 2019 Resolution asked for this same report and after
- 72 lengthy discussion, Senators decided instead to ask for an analysis of the "root causes" underlying
- 73 USC's recent scandals and an explanation of how the Administration proposes to overcome them.
- 74 President Folt has apologized for the delay in preparing this analysis and indicated that it is
- 75 forthcoming. Some Senators argued that a new Resolution was needed given an apparent
- 76 contradiction between the Administration's assertions that there was no written report and a
- 77 recent LA Times story suggesting that such a report exists. Adler moved to table the Resolution
- ⁷⁸ until the Senate has heard President Folt's response to the November 2019 Resolution.
- 79 *Motion to table the Resolution.* Seconded and passed: 33 in favor, 5 opposed, and 0 abstentions.
- 80 Draft Resolution on Divestment

- 81 The EB brought a draft Resolution on Divestment in support of a recent Resolution passed by the
- 82 Undergraduate Student Government Senate that urges USC to commit to a transparent and rapid
- sale of its investments in the fossil fuel industry, to reinvest the freed funds in clean technologies
- 84 and renewable energy, and to consider climate risk in its investing strategy. This request is
- 85 consistent with the Academic Senate's 2018 Resolution on USC's commitment to sustainability.
- 86 Motion to support the Undergraduate Student Government Senate Resolution on Divestment.
- 87 Passed: 34 in favor, 2 opposed, and 4 abstentions.

88 Announcements

- 89 Adler followed up on issues raised in the November Senate meeting:
- 90 Questions were raised about the trauma-informed approach used by staff working in our
- 91 central EEO-Title IX and OPE offices. Adler forwarded the concerns to Vice President Catherine
- 92 Spear who has agreed to address these questions at a Spring Senate meeting.
- 93 Some Senators have asked if the Senate could hear from the Board of Trustees. Adler plans
- to invite the Chair of the Board of Trustees and the newly-formed Medical Enterprise Board to
 meet with the Senate.
- 96 The EB has developed a Task Force to more deeply examine salary equity and
 97 transparency.
- Adler will forward concerns related to the connection between sexual assault and Black at
 USC to Sarah Van Orman, Chief Health Officer of USC Student Health, whom he expects to invite
 back to a future Senate meeting.
- The EB is exploring the viability of hosting a Faculty listserv or bulletin board.
- 102 A Senator expressed hope that the EB and EB members serving on CoFE will share with 103 administration that the Senate has offered ideas for saving costs and generating revenue.
- 104 Adjournment
- 105 Meeting was adjourned at 4:10 pm.
