27 28	Call to order: Margo K. Apostolos, Senate President Academic Senate President Apostolos called the meeting to order at 2:01pm.
29 30 31 32 33	Welcome Dr. Howard Hu, Professor & Flora L. Thornton Chair, brought a welcome and greeting from the Department of Population and Public Health Sciences, Keck School of Medicine. He gave an overview of the department's size and work.
34 35 36 37 38 39	Discussion with President Carol Folt and Provost Andrew Guzman President Folt recognized the first USC celebration Native American Heritage Month. More than 300 people attended and participated. President Folt also shared statistics about the current student demographic who identify as Native, Indigenous, and Pacifica, which has increased from 458 undergraduates and 356 graduate students in 2019 to 515 undergraduates and 375 graduate students. She shared "when we have numbers, we can help people feel more

41 belonging and see themselves and know more about their voice."

- 42 President Folt addressed the current state of affairs with regard to those affected by the events
- 43 in Gaza. She shared that "we are in a moment that is affecting so many people." The USC's
- 44 Network of Informational and Support Resources in Times of Conflict page is updated
- 45 regularly. USC hosted the first seminar on anti-semitism in higher education last week.

47 Provost Guzman recognized the Office of Student Life, Religious Life, and DPS as these offices 48 have done a fantastic job of ensuring the safety and support of students. He thanked all faculty, 49 many of whom have been affected directly, but also who care for our students. Provost 50 Guzman recognized that "a lot has to happen in the classroom and in the lab on a student level" 51 and "we just haven't had an enormous amount of dissatisfaction and unrest in the classroom 52 and that tells me that faculty are doing the right thing and ensuring the educational mission 53 continues." He encouraged faculty to, whenever possible, to treat people with respect and act in ways that are building community.

56 A Senator asked about whether Native American scholarships would be made difficult due to

- 57 the Supreme Court decision? President Folt shared that there is a team working on this and that
- 58 there are many ways to bring prospective students in that have interests in these areas. She
- 59 added that we have every right to be more aggressive in our pre-admission process so that
- 60 we're more diverse in our applicant pool. Provost Guzman added that the Supreme Court
- 61 decision is relatively narrow in that it's focused on the admissions decision.

63 A Senator asked about concerns regarding free speech for faculty. Provost Guzman shared that 64 a lot of what's online is not accurate in many different ways but the University wants to make 65 sure that the campus remains safe. One of the things the University has managed to avoid on 66 campus is confrontations. President Folt added that no one has been removed from 67 campus. She added "we are deeply concerned about safety. If we think there's real risk, we will 68 act to protect the people while we try to understand it." A suggestion was made to clarify 69 language in the Faculty Handbook so that people have a clearer understanding of matters 70 pertaining to faculty academic freedom and freedom of expression.

72 A Senator asked whether retired faculty have academic freedom. President Folt noted that 73 academic freedom pertains to doing your job, teaching a class, etc. She posed the question, 74 "What is the university's responsibility to this?" and stated that "It's more complicated than it sounds."

- 77 Provost Guzman shared that a Union strike date is scheduled for November 28th if there isn't
- 78 an agreement. Andy Stott has been reaching out to Deans of Faculty to prepare for the
- 79 eventuality of a strike. Provost Guzman asked faculty to make sure that they have access to
- 80 their own research. "How will you complete your teaching responsibilities if there is a strike?"
- 81 He shared that the rules around influencing students are complex and unfavorable to
- 82 employers so it's important to not persuade a student to not strike. It's also the case that if a
- 83 grad student chooses to come to work, they are entitled to do so and that's absolutely ok.

- 85 Health and Safety Discussion

- 86 Dr. Sarah Van Orman, Vice President and Chief Campus Health Officer, gave an overview of her
- 87 role and vision around campus health to support student, staff, and faculty. She discussed
- nutrition, Mental Health, and Sustainability and how we make choices that impact ourselvesand our community.
- 90
- 91 Dr. Van Orman noted a convening of the Well Being Collective on Monday, November 13 to
- 92 discuss how to promote student wellness. Her office will collaborate with the Office of Student
- 23 Live and Chris Manning's office to bring Jean Twenge, a national expert on generations, to
- 94 campus in February to discuss how generations are functioning both in the academic as well as95 the workplace.
- 95 96
- 97 Past President Pecchenino asked about the overlap of students and mental health. Dr. Van
- 98 Orman shared information about the Student Wellbeing Index Survey which looks at eight key
- 99 performance indicators. The measures they are following are "flourishing" and "belonging."
- 100 They have good longitudinal data from the last 5 years from that survey which includes data
- 101 from Counseling and Mental Health services. When looking at the undergraduates, they tend to
- be doing worse than graduate students with regard to belonging and flourishing. Anxiety is
- 103 more common than depression nationally in young adults.
- 104
- 105 Dr. Van Orman addressed questions around mental health first aid curriculum, suicide rates,
- 106 gender affirming care, first year and second year courses on consent for students,
- 107 resources/workshops for faculty, and Narcan resources.
- 108
- 109 Approval of the September and October Meeting Minutes; Christal Young, Secretary General
- Secretary Young presented the <u>September</u> and <u>October</u> Academic Senate meeting minutes for
  approval.
- Motion to approve September minutes. Seconded and passed. 26 in favor, 3 opposed, 1
  abstention.
- 114 *Motion to approve October minutes.* Seconded and passed. 25 in favor, 0 opposed, 0
- 115 abstentions.

- 117 Discussion on Graduate Student Unionization
- 118 Andrew Stott, Vice Provost for Academic Programs and Dean of the Graduate school provided
- 119 updates on graduate school unionization and strike. Of the students represented by United
- 120 Auto Workers, 97% are PhD students and 3% are masters students. The students voted to go on
- 121 strike on November 28th unless the University will offer them a "fair contract." The three
- 122 outstanding issues include:
- Wages The minimum stipend that a graduate student will make for 20 hours a week of
  work as a teaching assistant, research assistant, or assistant lecturer.
- Union security Whether students are obligated to become members of the union
  (closed union shop) or can elect to be members of the union or not (open union shop)
- Non-discrimination clause Codifies prescribed behaviors that the University will not
  tolerate. The union would like this clause to be subject to the grievance and arbitration
  clause and would have a parallel process.

- 131 Dean Stott encouraged faculty to consider alternative forms of grading in anticipation of the
- 132 pending strike.
- 133
- 134 A senator asked if faculty are able to ask whether students are going on strike. Stott shared that
- 135 faculty are not allowed to ask students about their intentions or activities around union
- 136 organizing. Faculty can continue to have discussions with them about their academic progress.
